

**ALPHA MEDIA'S CONTEST-SPECIFIC RULES FOR THE
Dream Wedding Package at The Pruneyard Wedding Fest featuring Trudys CONTEST**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

These contest-specific rules should be read in conjunction with Alpha Media's General Contest Rules, which are applicable to all contests conducted by Alpha Media Holdings LLC and/or its subsidiaries (including licensee subsidiaries).

1. Promotional Period: The Dream Wedding Package (the "Promotion") begins on or around Tuesday, August 6, 2019 at 2:45 PM PT and ends on or about Sunday, October 6, 2019 at 3:00 PM PT (the "Promotional Period").

2. Entry Deadline: The deadline to submit entries via Eventbrite is Saturday, October 5, 2019 at 4:00 PM PT. The deadline to submit entries on-site at event is Sunday, October 6, 2019 at 3:00 PM PT.

3. Eligibility Restrictions: The Promotion is open to all legal residents of the United States and the District of Columbia (except NY and FL) who are 18 years of age or older at the time of entry. Employees of 94.5 Bay FM/KBAY, Mix 106/KEZR (the "Stations"), Alpha Media, The Pruneyard and Trudys Brides (the "Sponsors"), their parent, subsidiary, and affiliated entities, their advertising agencies, participating sponsors/promotional partners, other broadcast stations in the Station's listening area, and the members of their immediate families (spouse, parents, siblings or children) or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations. Void outside the United States, in NY, RI and FL, as applicable, and where prohibited

Winner must provide a Valid ID to claim prize. Winner will also be required to fill out a W-9 form including social security number and valid address. This form and information will be used for tax purposes only.

Listeners are eligible to win an Alpha Media contest valued at \$600.00 or more only once every six months.

Unless otherwise specified in the prize notification: (1) all prizes or prize certificates may be picked up at the office of the stations conducting the Promotion, and (2) the winner will forfeit any prize or prize certificate not claimed within thirty (30) days of winning. Prize or prize certificates will not be mailed to the winner without the winner's prior written consent in which the winner shall agree to assume its risk of loss. Alpha, its promotional partner(s) and/or sponsor(s) are not responsible for the safe arrival of a prize or prize certificate.

Entrants can enter online contest once throughout the promotional period.

Entrants are required to provide truthful information and the Stations and Sponsors will reject and delete any entry that it discovers to be false or fraudulent. The Stations and Sponsors will disqualify any entry from any individual who does not meet the eligibility requirements, and will also delete any entry as required by law.

4. Entry Method: To participate in the Promotion, you may enter via the following method(s).

VIA EVENTBRITE – For this contest you must pre-register to attend The Pruneyard Wedding Fest featuring Trudys on Eventbrite at <https://www.eventbrite.com/e/the-pruneyard-wedding-fest-featuring-trudys-tickets-68209158429>. Only the person who registers and gives their information will be entered to win the Dream Wedding Package. Those put down as guests will not be entered into the contest. If a guest would like to be pre-registered they will need to enter their own information on the Eventbrite event page listed above in this paragraph. Required information, which may include your first and last name, address, telephone number, date of birth, and a valid email address, in the online form. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning the email address or the domain associated with the submitted email address. Multiple entrants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. The contest/sweepstakes administrator's computer is the official time-keeping device for the Promotion.

Entrants can enter the promotion once total, per email address between August 6, 2019 and Saturday, October 5, 2019 at 4:00 PM PT.

Pre-registering via the Eventbrite event page will get each registrant one entry into the Dream Wedding Package.

Those that pre-register must still check in at one of the two Registration tables at the event on October 6, 2019 between 11:00 AM PT and 3:00 PM PT to show they are present for the drawing. Winner must still be present immediately after the 3:00 PM PT Trudys Fashion Show when drawing takes place to claim prize.

VIA ON-SITE AT EVENT – For this contest you can:

- (1.) Visit Trudys Brides' booth at The Pruneyard Wedding Fest featuring Trudys on Sunday, October 6, 2019 between the hours of 11:00 AM PT and 3:00 PM PT and book an appointment at Trudys for a future date and time to receive an official entry form to receive one entry to win the Dream Wedding Package. Only the person who books an appointment and gives their information will be entered to win the Dream Wedding Package. Required information, which may include your first and last name, address, telephone number, date of birth, and a valid email address. Multiple entrants are not permitted to share the same required information. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station or Sponsors. The Stations are the official time-keeping device for the Promotion.
- (2.) Visit Alpine Travel of Saratoga's booth at The Pruneyard Wedding Fest featuring Trudys on Sunday, October 6, 2019 between the hours of 11:00 AM PT and 3:00 PM PT and fill out an official entry form to receive one entry to win the Dream Wedding Package. Only the person who fills out an official form and gives their information will be entered to win the Dream Wedding Package. Required information, which may include your first and last name, address, telephone number, date of birth, and a valid email address. Multiple entrants are not permitted to share the same required information. Entries submitted will not be acknowledged or returned. Use of any device to

automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station or Sponsors. The Stations are the official time-keeping device for the Promotion.

There is a max of three (3) entries per person total. One entry for pre-registration via Eventbrite. One entry for booking an appointment with Trudys Brides at event. One entry for visiting the Alpine Travel of Saratoga booth at event.

5. Prize: One (1) Dream Wedding Package will be awarded. Dream Wedding Package includes:

\$1,500 wedding dress credit for Trudys Brides (Approximate prize value is \$1,500.00).

\$1,000 Transportation credit for Corinthian Transportation (Approximate prize value is \$1,000.00).

\$1,000 credit to Cake Expressions (Approximate prize value is \$1,000.00).

Bridal Party Fitness Package from Barry's Bootcamp that includes two (2) class passes valid for ten (10) classes and four (4) class passes valid for five (5) classes. (Approximate prize value is \$1,200.00).

One year of tanning, sunless and spa unlimited use and products for red light (spa) sunless and tanning from Australian Tan (Approximate prize value is \$1,050.00).

Two night weekend stay at the DoubleTree by Hilton Campbell – Pruneyard Plaza in a Junior Suite with breakfast for two at PY Kitchen & Bar (Approximate prize value is \$1,000.00)

Six (6) day / Five (5) night honeymoon in Mexico in a swim-up junior suite at the all-inclusive Hotel Valentin Imperial Riviera Maya in Playa del Carmen. Land only prize - airfare to Mexico is NOT included. (Approximate prize value is \$5,000.00)

Approximate prize value of Dream Wedding Package is \$11,750.00.

There is no substitution, transfer, or cash equivalent for prizes. Prizes in Dream Wedding Package are non-transferrable to another person and not redeemable for cash. Cash will not be given for any or a portion of the prize not redeemed or used. 6. Odds of Winning: Odds of winning contest depend on the number of entries received from Eventbrite and from on-site at event.

7. Winner Selection and Notification: Decisions of Station management with respect to the Promotion are final. At the conclusion of the Trudys Fashion Show on Sunday, October 6, 2019 at or around 3:30 PM PT one (1) winner will be selected at random from all eligible entries by the Stations. That person's name will be called out live from the stage three (3) times. If the person is not present and does not make themselves known to the stage personnel after three announcements that person will be disqualified and another name will be selected at random from all eligible entries. That name will be called out live from the stage three times. If that person is not present and does not make themselves known to the stage personnel after three announcements that person will be disqualified and another name will be selected at

random from all eligible entries. This process will continue until we have one winner who is present to win and makes themselves known to the stage personnel.

If a portion of the prize is not available day of the event the winner will need to pick-up prize(s) at the offices of 94.5 Bay FM-Mix 106 located at 5225 Hellyer Ave, Suite 245, San Jose, CA 95138 between the hours of 9:00am to 5:00pm PT within thirty (30) days of station letting them know the prize(s) are available for pick-up.

8. Conditions:

a. Payments of all federal, state and local taxes are solely the responsibility of the winner. ii. Acknowledge that Alpha, The Pruneyard, and Trudys Brides reserves the right, in its sole discretion, not to use the Materials at all; and represent and warrant that: you are at least as old as the age of majority in your state; you have the full legal right, power and authority to grant to Alpha the license provided for herein; you own or control the complete exhibition and other rights to the Materials you submitted for the purposes contemplated in this license; you are either the parent (or legal guardian) of any minor featured in the Materials or have received the express consent of the parent (or legal guardian) for any such minor to appear in the Materials and to enter the minor's likeness in the Materials in the contest; and neither the Materials nor the exercise of the rights granted herein shall infringe upon or violate the right of privacy or right of publicity of, or constitute a libel or slander against, or violate any common law or any other right of, any person or entity.

d. Prior to awarding any prize or prize certificate, and depending on the nature of the prize and eligibility requirements of the Promotion, Alpha, The Pruneyard, Trudys Brides, or any vendor included in Dream Wedding Giveaway in its sole discretion may require verification of Promotion winner's identification by a showing of valid government-issued photo identification.

e. To the fullest extent permitted by law, by participating and/or accepting a prize, entrants, winner(s) and guests (if applicable) agree to release and hold harmless the station conducting the Promotion, its sponsor(s) and promotional partner(s), its advertising and promotion agencies, any social media platform utilized in the conduct of the Promotion (including but not limited to Facebook, Inc.) and each of their respective parent, subsidiary and affiliated entities, and the officers, shareholders, directors, employees, agents, representatives, successors, and assigns of each of them (collectively, the "Released Parties") against any and all claims or liability arising directly or indirectly from the prize or participation in the Promotion. Alpha may also require eligible Promotion winner(s) and their guests or travel companions, if any (as well as each of their parent(s) or legal guardian(s), if winner(s), guest(s) or travel companion(s) are under the age of majority in their state of residence), to sign a liability release confirming such consent. f. The station conducting the Promotion, in its sole discretion, reserves the right to disqualify any person (and all of their entries) from this Promotion if he or she tampers with the entry process, the operation of the Promotion, or the operation of the station's website, Facebook Page, and/or any other social networking site used in the Promotion, or is otherwise in violation of the rules. The station conducting the Promotion further reserves the right, at its sole discretion, to modify, cancel, terminate or suspend the Promotion, or any part of it, if it is not capable of completion as planned or if any fraud, technical failures or any factor beyond the station's control, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort, corrupt or affect the administration, security, fairness, integrity or proper conduct of the Promotion as determined by the station in its sole discretion. Any attempt by an entrant or any person to deliberately damage any station website, Facebook Page, and/or any other social networking site used in the Promotion or to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws. Should such an attempt be made, the Alpha reserves the right to seek full prosecution and/or damages from any such individual to the fullest extent permitted by law. The station's failure to enforce any term of these Official Rules shall not constitute a waiver of this provision. If due to circumstances beyond the control of the station conducting the Promotion, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the station reserves the right, but not the obligation, to modify, terminate, suspend or cancel the Promotion and shall not be required to award a substitute prize.

g. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion, or in the announcement of a prize; (ii) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, malfunctions, disconnections, other technological failures, telephone service outages, delays, dropped calls, or busy signals, or any other difficulties that may prevent an individual from sending or receiving a text message; or (iii) lost, stolen, mangled, misdirected, postage due, illegible, incomplete, incorrect, or late entries. Further, the Released Parties are not responsible if any part of a Promotion prize cannot be awarded due to acts of god, acts of war, natural disasters, weather, acts of terrorism or other factors beyond Alpha's control.
